Introduction

In this publication, Statistics Centre - Abu Dhabi (SCAD) is providing statistical estimates of Non-Profit Institutions Serving Households (NPISH's) in the Emirate of Abu Dhabi for 2013. Official statistics provide current, accurate and objectives data as one of the most important pillars of a sustainable comprehensive planning and development process that supports decision-making. It contribute to the achievement of the Emirate's development objectives and vision and also fill the gap in the data related to this sector, which is the fifth sector of the system of national accounts.

NPISH's are non-government institutions such as charities, sports and cultural clubs, theaters, public libraries, women, children and family welfare societies, and Holy Quran memorization societies that provide goods or services (outputs) to households for free or at prices that are not economically significant.

The data sources used to estimate the NPISH sector were:

- Statistics and the actual data obtained from the Ministry of Social Affairs in the form of administrative records for 2013.
- Data from the clubs operating in the Emirate of Abu Dhabi after contacting them directly.

Statistics of Non-profit Institutions Serving Households

The total revenues of NPISH's amounted to AED 491.6 million in 2013, while total expenditure was AED 777.3 million in the same year.

The expenditure on compensation of employees amounted to AED 534.7 million or 68.8% of the total, while general and administrative expenses accounted for 27.7% (AED 215.8 million) of total expenditures.

Expenses on activities consumed was AED 19.1 million, representing 2.5% of total expenditure, while rents and utilities represented 0.26% and 0.01% of the total expenditures, with amounts of AED 2.0 million and AED 95 thousand, respectively.




Figure 1: Distribution of expenditures by type

Revenues from contributions and grants represented 5.0% (AED 24.6 million) of the total revenues in 2013. Revenues from activities amounted to AED 56.7 million or 11.5% of total revenues. Membership fees amounted to AED 6.0 million, representing 1.2% of total revenues, while other revenues generated AED 404.0 million, or 82.3 percent of NPISH's total revenues in 2013.




Figure 2: Distribution of revenues by type

Glossary

AED: Arab Emirates Dirham

Non-Profit Institutions Serving Households (NPISH's): non-government institutions that provide goods or services (outputs) to households for free or at prices that are not economically significant, such as charities, sports and cultural clubs, theaters, public libraries, women, children and family welfare societies, and Holy Quran memorization societies.

Total expenditures: the value which is paid by NPISH's to play its role in serving households in the Emirate of Abu Dhabi.

Compensation of Employees: include salaries and wages paid in cash which include additional salaries and bonuses. Also include in kind and social benefits provided to employees.

Total revenues: the received value by NPISH's from membership fees, contributions and grants as well as what has been paid for them in regard to the goods or services (outputs) provided to households for free or at prices that are not economically significant.

Membership fees: the monthly or annual amount paid by members of NPISH's.

Percentage contribution: Relative importance of an item within the total revenues and expenditures in comparison with other items.
