### Introduction

This report presents statistics on marriage and divorce in Abu Dhabi Emirate during the period 2002–2011. It contains marriage contracts, crude, general and refined marriage rates, (SMAM) singulate mean age at first marriage as well as divorce cases, crude, general and refined divorce rates.

The first section provides a brief summary of the key statistics supported by figures to highlight trends, regional variation and seasonal patterns.

The second section provides detailed statistical tables for readers who wish to analyse the data more closely.

The main source for these statistics is the Judicial Department - Abu Dhabi (ADJD). SCAD acknowledges the productive partnership with ADJD which aims to continually improve the coverage and quality of marriage and divorce statistics.

The Explanatory Notes section at the end of this report provides an explanation of the key terms and technical concepts used for marriage and divorce. Readers are encouraged to refer to that section in conjunction with reading the statistics and information outlined in the report.

## **Key Points**

- In 2011, there were 5,708 marriages contracts compared with 4,714 and 5,328 in 2002 and 2006 respectively. Representing a rise of 21.1% in nine years. However, there was a decrease of 140 (2.39%) from 5,848 in 2010.
- The Crude Marriage Rate decreased to 2.7 marriages per 1000 population in 2011, while it was 3.9 marriages per 1000 population in 2002.
- The Crude Marriage Rate was highest level in Al Ain region with 3.8 marriages per 1000 population in 2011.
- While in 2002, only 72.1% of the male citizens married female citizens, this percentage increased to reach 76.4% in 2011.
- There were 1,803 divorces in 2011 compared with 1,661 in 2002, representing a rise of 8.54% in nine years.
- In 2011, the Crude Divorce Rate reached 0.9 with its highest level in Al Ain region with 1.0 divorces per 1000 population.
- In 2011, the Crude Divorce Rate decreased by 0.5 divorces per 1000 population compared with 2002.

### **Marriage and Divorce Trends**

The total number of marriages registered in 2011 in Abu Dhabi Emirate was 5,708. This was 4.1 times the 1,402 marriages registered in 1987.

By comparison, there were 951 divorce cases in Abu Dhabi Emirate in 1987. It increased to 1803 cases in 2011, representing an increase of only 1.9 times during this period.

### **Marriage Indicators**

### **Marriage Contracts**

Administrative records show a rise in marriages in Abu Dhabi Emirate in the registrations. The number of marriage contracts in 2002 totalled 4,714. It increased significantly to reach 5,328 contracts in 2006. Then, it continued rising until it reached 5,708 contracts in 2011, representing an increase of 21.1% during 2006 to 2011.

Classifying marriage by citizenship, the number of male citizen marriages decreased from 3642 in 2010 to 3521 in 2011. Similarly, male non-citizen marriages decreased over the same period. Across the regions, 49.4% of male citizen marriages registered in Abu Dhabi Region and 44.8% and 5.7% of the male citizen marriages were registered in Al Ain region and Al Gharbia region respectively. The same pattern applied to female citizens' marriage contracts with 48.2%, 45.5 % and 6.3 % for Abu Dhabi Region, Al Ain Region and Al Gharbia respectively.





Figure 2: Percentage Distribution of Citizen Marriage Contracts by Region and Gender, 2011

### **Crude Marriage Rate**

In 2002, the Crude Marriage Rate (CMR) was 3.9 marriages per 1000 population. It decreased steadily until 2006 to reach 3.6 marriages per 1000 population. Moreover, in 2010 to 2011 the CMR declined from 3.0 to 2.7 respectively.





----- Crude Marriage Rate

The results shown indicate that the CMR in the Emirate of Abu Dhabi was 2.7 marriages per 1000 population in 2011. This rate varies between different regions of the Emirate, reaching its highest level in Al Ain region with 3.8 marriages per 1000 population, followed by Abu Dhabi 2.5 marriages per 1000 population and Al Gharbia 1.1 marriages per 1000 population. The Crude Marriage Rates showed no significant difference between the rate of male and female citizens except in the Al Gharbia where the CMR for the males was 14.1 while it was 19.3 for the females. In addition, for non-citizens, the CRM for males is significantly less than the CRM for the females as shown in the figure below




Figure 4: Crude Marriage Rates (per 1000 population) by Region, Citizenship and Gender, 2011

### **General Marriage Rate**

The General Marriage Rate (GMR) in the Abu Dhabi Emirate in 2011 was 3.3 marriages per 1000 population aged 15 years and above. Among citizen married male, the GMR reached 25.2 while it reached 23.9 among citizen married females. The value of GMR varies between the regions of the Emirate among which Al Ain region ranked top, with 4.8 marriages per 1000 population aged 15 years and above, followed by Abu Dhabi 3.0 marriages per 1000 population aged 15 years and above and the Al Gharbia 1.2 marriages per 1000 population aged 15 years and above.




Figure 5: General Marriage Rates (per 1000 population aged 15 years and above) by Region, Citizenship and Gender, 2011

# **Refined Marriage Rate for Citizens**

The Refined Marriage Rates for 2011 vary by region and gender, reaching its highest level for males in AI Ain Region at 23.5 marriages of males, per 1000 unmarried male at aged 15 years or above. Its highest level for females was in AI Gharbia at 45.1 marriages of females, per 1000 unmarried female at aged 15 years or above.




Figure 6: Refined Marriage Rates for Citizens by Region and Gender, 2011

# Singulate Mean Age at first Marriage for Citizens

The median age at first marriage (SMAM) of Abu Dhabi Emirate in 2011 was 27.7 years for males and 26.1 years for females. In general, SMAM has increased about one year from 2001 to 2011. For male citizens, SMAM rose from 25.9 years in 2001 to 26.7 years in 2011. For female citizens, it rose from 24.6 years to 25.7 years in the same period.




Figure 7: Singulate Mean Age at First Marriage for Citizens by Gender, 2001, 2005 and 2011

### **Mixed Marriages**

In 2011, there were 1286 marriage contracts where one of the spouses is citizen while the other is not citizen. While in 2002, only 72.1% of the male citizen married female citizen, this percentage increased to reach 76.4% in 2011.





Figure 8: Male Marriage Rates by Citizenship, 2002, 2006, 2010 and 2011

Moreover, the percentage of the male citizens who married female citizens declined in 2011 compared to 2006 in all regions. Nevertheless, Al Gharbia male citizens had the highest prospective to marry female citizens 90.6% than other regions in 2011. Also, the percentage in Abu Dhabi Region and Al Ain Region were 71.6% and 79.9% respectively.





On the other side, Abu Dhabi Region has the highest rate of male non-citizens who married female citizens from 2002 until 2011. In 2002, the rate of male non-citizens who married female citizens was 6.0% in Abu Dhabi Region followed Al Ain Region with 3.1%. Also, it decreased for all regions in 2006 except Al Gharbia. While in 2011, the rate decreased again to reach 4.7% in Abu Dhabi region, 3.0% in Al Ain region and rose relatively in Al Gharbia 0.3%.




Figure 10: Marriage Rates between Female Citizens and Male Non- Citizens, 2002, 2006 and 2011



# **Divorce Indicators**

### **Divorce Contracts**

Administrative records show a rise in Divorces in Abu Dhabi Emirate in the registrations. The number of divorce contracts in 2002 totaled 1661. It increased to reach 1733 contracts in 2006. Then it increased until it reached 1803 contracts in 2011, representing and rose of 4.04% during 2006 to 2011.

On other hand, the number of citizen male divorces rose from 2010 to 2011. Also, 60.2% of citizen males' divorces registered in Abu Dhabi Region were 36.9% and 2.9% of the citizen males' divorces were registered in Al Ain Region and Al Gharbia respectively. The same pattern applied to female citizens' divorce contracts with 60.0%, 36.5 % and 3.6% for Abu Dhabi region, Al Ain region and Al Gharbia respectively






### **Crude Divorce Rate**

In 1987, the Crude Divorce Rate was 1.6 per 1000 population and it decreased to 1.0 in 1998 then increased to 1.4 in 2002. There is a clear decline in the crude divorce rate in 2006 and 2011 reached 1.2 and 0.9 per 1000 population respectively.





The Crude Divorce Rate (CDR) in the Emirate of Abu Dhabi was 0.9 divorces per 1000 population in 2011. The value of this rate varies between the regions of the Emirate, reaching its highest level in Al Ain Region with1.0 divorces per 1000 population, followed by Abu Dhabi Region 0.9 divorces per 1000 population, and then the Al Gharbia 0.2 divorces per 1000 population. In general, the highest level of CDR for male and female, citizen or non-citizen in Abu Dhabi Region followed Al Ain Region and Al Gharbia. Moreover, CDR for male citizens and female citizens was 5.6 and 4.7 per 1000 population respectively in Abu Dhabi Region. Also, the CDR in Al Ain Region was 4.6 for male citizens and 3.7 for female citizens. Female citizens had higher CDR than male citizen in Al Gharbia. The CDR showed significant difference between the rate of male and female non-citizen except in Al Gharbia where the CDR for male was 0.1 while it was 1.2 for female, while Abu Dhabi Region 2.3 and 0.6 for female and male respectively.




Figure 13: Crude Divorce Rates (per 1000 population) by Region, Citizenship and Gender, 2011

## **General Divorce Rate**

The General Divorce Rate (GDR) in the Abu Dhabi Emirate in 2011 was 1.0 divorces per 1000 population aged 15 years and above. The value of this rate varies geographically in the Emirate, reaching its highest level in Al Ain Region at 1.3 divorces per 1000 population aged 15 years and above, followed by Abu Dhabi at 1.1 divorces (per 1000 population aged 15 years and above, and Al Gharbia 0.2 divorces per 1000 population aged 15 years and above. Abu Dhabi Region has the highest GDR for citizen and non-citizen followed Al Ain Region and Al Gharbia.




Figure 14: General Divorce Rates (per 1000 population aged 15 years and above) by Region, Citizenship and Gender, 2011

# **Refined Divorce Rate for Citizens**

This rate varies between the regions of the Emirate, being highest in Al Ain Region, with 2.9 and 6.6 divorces for male and female respectively per 1000 unmarried population aged 15 years and above, followed by Abu Dhabi Region where divorce rate for male 2.5 and female 4.3 per 1000 unmarried population aged 15 years and above. Finally, Al Gharbia had the lowest refined divorce rate.




Figure 15: Refined Divorce Rates for Citizens by Region and Gender, 2011

### **Explanatory Notes**

### Glossary

This report contains certain terms specific to marriages and divorces. They include the following terms:

#### **Crude Divorce Rate**

The crude divorce rate within a given region/country in a specific year/period of time is defined as the number of divorces (and not the number of divorced couples) per 1000 population in that region/country in the specified year/period of time.

Number of divorces during the reference year Estimated population in the middle of the of that year \* 1000

### **Crude Marriage Rate**

The crude marriage rate in a given region/country in a specific year/period of time is defined as the number of marriages (and not the number of married couples) per 1000 population in that region/country during that year.

 $\frac{\textit{Number of marriages during the year}}{\textit{Estimated population in the middle of the year}}*1000$ 

### **General Divorce Rate**

The General Divorce Rate in a given region/country in a specific year/period of time is defined as the number of divorces (and not the number of divorced couples) for every 1000 of the population aged 15 years and above in that region/country in the specified year/period of time.

 $\frac{\text{Number of divorces during the reference year}}{\text{Estimated population aged 15 years and above in the middle of that year}}*1000$ 

### **General Marriage Rate**

The general marriage rate in a given region/country in a specific year/period of time is defined as the number of marriages (and not the number of married couples) per 1000 population aged 15 years and above.

Number of marriages during the year Estimated population aged 15 and above in the middle of that year \* 1000

#### **Refined Divorce Rate**

The refined divorce rate within a given region/country in a specific year/period of time is defined as the number of divorces (and not the number of divorced couples) per 1000 married population aged 15 and above in that region/country in that year/period of time.

Number of divorces during the year Estimated married population aged 15 years and above in the middle of that year

#### **Refined Marriage Rate**

The refined marriage rate in a given region/country in a specific year/period of time is defined as the number of marriages (and not the number of married couples) per 1000 unmarried population (who have never been married, or who are divorced or widowed) aged 15 years and above within that region.

Number of marriages during the year Estimated population who have never been married or who are divorced or widowed aged 15 year and above in the middle of the year

### Singulate Mean Age at First Marriage

Average number of years lived unmarried before the first marriages for those who will ultimately marry by age 50.

#### Data sources

The marriage and divorce indicators used in this study were calculated on the basis of the statistical figures issued by the Abu Dhabi Judicial Department and the population estimates prepared by the Statistics Centre- Abu Dhabi.

- SMAM Singulate Mean Age at First Marriage

### **Cautionary Note**

It is important to note that the ratio of divorces to the number of marriages in a given year does not represent the rate of divorces for that year, because the divorces relate to marriages of many previous years. For this reason, this ratio should not be used to evaluate trends in divorce rates.
